

DRIVER EDUCATION STANDARDS: Tools & Resources

The Association of National Stakeholders in Traffic Safety Education (ANSTSE) with the support of the National Highway Traffic Safety Administration (NHTSA) has developed and maintains the following driver education assessment tools and resources:

- An Information Sharing System, which is a free online, self-assessment tool for States to enable them to gauge the extent to which their current teen driver education program aligns with the NTDETAS. The tool is available at the ANSTSE website at http://www.anstse.info/Survey/survey/index.php.
- A state review of driver education programs facilitated by NHTSA (the NHTSA State Driver Education Assessments) which aims to identify gaps and recommend improvements. This review can provide a solid foundation to begin the implementation of the NTDETAS.
- Technical assistance delivered by key experts in the field through ANSTSE. Information on requesting technical assistance is available on the ANSTSE website at http://www.anstse.info/Technical%20Assistance.html.
- A website (www.anstse.info). dedicated to the implementation of the NTDETAS that contains the standards, resources and other tools, including:
 - A checklist to guide activities to implement the Standards.

 - Research reports, including recent evaluations of driver education.

- 2017 NTDETAS Strategic Plan.
- 2017 model training curriculum for the teaching task instructor's guide.
